CCTV	Mr. L Van Dyk	<ul style="list-style-type: none"> • 8 Camera's currently belong to council out of 200 camera's the rest is all Neighbourhood watches inside this facility. • Council provide Infrastructure & free Electricity, to make sure everything is governed and run-in appropriate manner. If you want to put on camera's, it must be running through a specific process, it must run through legal services you will be given permission, and then the data runs through the Centre. • The goal is to run all the information that comes from various partners into the Centre it's build modular, infrastructure that have been created includes the screen, computer & NVR, which is board by the Neighbourhood watches, placed into the Centre remains the property of Neighbourhood watches, but is managed in appropriate manner and the information is save guarded. • In the next few weeks Mid-brak, Heiderand Golf Estate will be streaming in the Centre and be coming on board. • The objective is to run about 500 cameras', could run up to a 1000 camera's build, manage and own modular. • A decision was made for Neighbourhood Watches for a contribution of R500 a month, is the average contribution we aspect for someone to pledge. • We will start putting up infrastructure in specific areas to rollout camera's, infrastructure have been created along corridors already, to make sure we roll it out to another Centre's. • High mast will be used, will be starting as a phase 1 in the Aslam & KwaNonqaba where camera's will be rollout in high mast areas, also hotspots areas. It will enable us to see people putting up shacks illegally, illegal power connection will be spotted, fires will be seen from the air, and crime will be evaluated from these areas. • Currently using Law enforcer students to manage
